Please find attached an Appendix 3B (New issue announcement) in relation to the Eumundi Group Limited Dividend Reinvestment Plan (“**DRP**”) for the fully franked interim dividend of 3.2 cents per share paid on 18 March 2019.

In accordance with the Rules of the DRP, the VWAP during the pricing period was 85.911 cents per share, and issue price of shares under the DRP was **81.62 cents per share** after adjusting for the 5% discount.

The Board of Eumundi Group is pleased with the continued high level of participation by shareholders in the DRP which was again in excess of 96%.


